

In addition to your normal monthly electric bill, you pay a small additional charge each month to offset the additional cost it takes to support renewable energy. Evergreen comes from solar, wind, and waste-to-energy renewable resources. Your participation in Evergreen enables Bayfield Electric to secure additional renewable energy recourses above and beyond government requirements. Ashland County Housing Authority is the administrator for Bayfield Electric's "Commitment to Community" program.
